Opened to the public in 1986, starting in an empty space in a high school, Poets House became a comprehensive, 80,000-volume poetry library and a national home for the art, producing over 250 poetry events a year, and training public libraries around the country through a model for the development of poetry services. In Fall 2009, after managing a six-year, \$11.5M capital project (including negotiation of 60-year, rent-free lease in Battery Park City), Poets House opened its permanent facility, one of the great places for poetry on the globe. Prior to the pandemic, Poets House welcomed 80,000 people annually to this facility and served millions via online and national outreach.

- Directed management, fundraising and long-range planning, raising over \$35M from public and private sources throughout tenure. Oversaw development of programs and services. Acted as liaison to the Board of Directors and committees. In 2020, the operating budget rose to \$1.5M (up from \$70,000 in 1989).
- Founded and developed The Poetry Publication Showcase in 1991, the only on-going annual exhibition of the year's new poetry books in the U.S., which became Poets House's collection development mechanism.
- Founded and developed Poetry in The Branches (PITB), a model for comprehensive poetry services in community libraries. Originally set in nine library satellite sites, PITB became a nationally known model program affiliated with the American Library Association, traveling to library systems throughout the country. An annual National Poetry in The Branches Institute, initiated in 2002, brought librarians to Poets House for a three-day seminar on creating poetry services in diverse library settings.
- Co-developed and co-curated The People's Poetry Gathering, a biennial festival throughout Lower Manhattan celebrating oral and written poetries. The Gatherings attracted audiences of 10,000 and created annual affiliations with over twenty other presenting organizations (1999, 2001, 2003).
- Developed the Poets House Poetry Walk Across the Brooklyn Bridge, now in its 27th year.
- Curated, organized and introduced thousands of poetry events.

- Directed the agency's partnership role in development of six NHS offices; coordinated the City's four-year funding commitment of \$2.5M.

- Coordinated successful team campaign to raise private contributions from commercial and savings banks and insurance companies. Funds used to leverage federal monies through an Urban Development Action Grant (for multifamily dwelling energy efficiency program).
- Edited and co-authored: 1) Residential Energy Assistance Urban Development Action Grant requesting \$4M to match the \$10M in private contributions; 2) A Proposal for the 312 Multifamily Demonstration in New York City (\$500,000 in 312 funds received).
